## Counseling Corner Suggestions for emotional regulations



Let's face it. Emotions are a part of life. Mastering the regulation of these emotions can take decades of practice. How do we even learn about emotions and what to do with them? As caregivers increase their knowledge in helping themselves, they help children in their care learn to regulate emotions. It is extremely necessary for adults to practice and model positive regulation strategies. As children, we learn through observation. Here are a few key strategies to help children make positive choices and regulate their emotions:

- Model desired behaviors. Be an example for your children. They watch how you interact with people and how you handle difficult situations. For example, if saying "please" and "thank you" are important to you, do so to and around you children. "I see that we are both frustrated. Let's take a break to calm down and gather our thoughts. We can continue this discussion once we are able to listen to one another."
- Name your emotion. You increase your child's vocabulary of emotions by naming and labeling the emotions you are experiencing.

"I am feeling nervous that we will not get to school on time."

"I am feeling sad because I don't get to see my sister very much."

- Discuss your process for solving the experience. It is normal to have feelings. It is important to recognize and validate these out loud so that children learn emotions are valid and see ways to express and resolve strong emotional experiences. "I am feeling annoyed right now. I am going to step away to breath and calm down."
- Own your mistakes. Caregivers may find it difficult to talk about how a situation was poorly handled by them. However, talking with your child about the mistake and how it would have been better to handle the situation helps your child in two ways. It allows the child to learn the reality that no one is perfect, and everyone can evaluate situations to find better ways to solve the situation, problem, or conflict.

"I was frustrated when we were talking earlier and did not speak to you the way I should have."

# FAMILY ADVOCATE CORNER

Did you know...

That everyone is a mandated reporter in the state of Florida. Although there are two different types of mandated reporters.

The **General Reporter** is defined in Florida State Statue as any person who knows, or has reasonable cause to suspect, that a child is the victim of abuse, abandonment or neglect by parent, legal guardian, caregiver, or other person responsible for the child's welfare.

The <u>Professional Reporter</u> is defined as anyone who is legally obligated to report known abuse and MUST identify themselves when reporting. This includes but is not limited to: Physician, medical examiner, chiropractic physician, nurse, paramedic, emergency medical technician, or hospital



personnel engaged in the admission, examination, care, or treatment of persons, Health or mental health professional, Social worker, day care center worker, or other professional childcare, foster care, residential or institutional worker (child), Employees of Department of Business and Professional Regulation conducting inspections of public lodging establishments, Law enforcement officer, Judge, and Mediators.

For more detailed information please see chapter 39 of the Florida state statutes.



#### Be a hero. **Spot the signs of abuse**.

Learn these 10 signs of child abuse and make the report. You may be the only one who will.

- 1. Unexplained injuries
- 2. Changes in behavior
- 3. Returning to earlier behaviors
- 4. Fear of going home
- 5. Changes in eating
- 6. Changes in sleeping

- Changes in school performance and attendance
- 8. Lack of personal care or hygiene
- 9. Risk-taking behaviors
- 10. Inappropriate sexual behaviors

As the experts in child abuse and neglect assessments, CPT performs our vital services through specialized interviews (with caregivers and or extremely younger children), forensic interviews and medical examinations. Our case coordinators and medical team assist our community partners in determining abuse or neglect and if a child is safe in their environment. We also make service recommendations for family changes to help improve family functioning and overall child safety.

Our main office is in downtown Leesburg. We offer satellite services in Sumter County, Clermont, and Tavares. These satellite offices allow families to be served closer to their home with a familiar community environment, alleviating inordinate transportation costs which can add up.
